Section 2: Use of Data Collected

- Any email from us will include the ability to unsubscribe from future email messages.
- Unsubscribing will ensure the customer is removed from ALL lists at EPIC Renewal Concepts, Inc. (dba Hypnotherapy by Jenny); this excludes customer service emails regarding the processing and status of a current product.
